# Introduction - SEA Stakeholder Engagement Plan

Covers an integrated Public Participation Process (PPP) across both Work Package 1 (WP1) and Work Package 2 (WP2) of the SEA.



Aims to keep stakeholders informed, involved, and able to contribute meaningfully to the SEA.

Note Designed as a living document/plan to evolve with stakeholder input throughout the SEA process.

- Ongoing nominations for broader representation.


# **Working Group Meetings to Date**

### Second Meeting – 10 October 2024:


- Provided an overview of the proposed Boegoebaai Port, SEZ, and the broader regional GH<sub>2</sub> development programme.

# **Draft Findings for Comment**


SEA will entail comment windows during which the public can provide input to the SEA outputs.

Draft SEA reports will be available for a 30-day public comment period via the CSIR website, with executive summaries in Afrikaans and stakeholder consultation meetings held.





All comments will be documented in a Comments and Response Report, to be published on the SEA website for transparency.


# **Closing Reflections**

### Based on today's discussion, some key take-aways:

- The SEA is not a decision-making process, it seeks to guide future decisions by looking at the possible risks and opportunities of the proposed Boegoebaai development programme, and how risks can be minimized and benefits enhanced.
- This SEA does not intend to result in regulatory streamlining or to circumvent any project level assessment, engagement or decision-making. It does seek to provide an evidence base, transparent and available to all, to support future policy, planning and decisions.
- Engagement spans across:



- The SEA (via CSIR) that is occurring now (inter alia this WG meeting) and for the duration of the SEA. Focussed on SEA content and outcomes.
- Policy/programme-driven communication (via e.g. Government, NCEDA, TNPA) which has occurred in the past, is ongoing now and into the future.
- Plans (e.g. SDFs, IPDs) in the future.
- Projects (e.g. future EIAs) in the future.



# **Next Steps**

- CSIR to draft WG meeting notes of key issues and action items & upload to project website
- Expectations over the next 6 months:
  - Lead Authors to present WP2 draft findings to WG (~Jun 2025 meeting)
  - SEA specialist chapters shared for formal review process by WG
  - Two online webinar/briefing sessions for the wider stakeholders ~ May 2025 & June/July 2025 for WP1 and WP2, respectively
    - Lead Authors to present the relevant specialist chapters draft findings
  - Local briefings in ~ six locations (Lekkersing, Kuboes, Eksteenfontein, Sanddrift, Port Nolloth/Alexander Bay & Springbok), and will consist of two rounds:
    - Round 1: June/July 2025 (aligned with WP1 draft SEA report).
    - Round 2: September/October 2025 (aligned with WP2 draft SEA report).

#### Other actions captured during the meeting:

- CSIR to create case of SAHRIS to enable SAHRA comment on documents.
- CSIR to consider how comment period can be maximized to enable meaningful engagement with the reporting.
- Any comments from this session pertaining to chapter content be taken on board, where possible, ahead of draft for comment (e.g. checking spp threat status).
- Specialist / theme-specific session/s on biodiversity with counterparts (e.g. SANBI, BirdLife etc.) to engage on technical content.
