5 PRICING QUOTATION

- 3.3 **Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.** For VAT registered bidders, the VAT component and the total price including

VAT should be clearly indicated.

- 5.1 Price should include all additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.2 Payment will be according to the CSIR Payment Terms and Conditions.

6 OTHER TERMS AND CONDITIONS
