1. INVITATION FOR QUOTATION

Quotations are hereby invited for the provision of SAP Business One upgrades, implementation of Eralis Project Management and Fiori for ESS/MSS in four different locations for CSIR's beneficiary companies (**see ANNEXURE A for detailed requirements per site/locations**)

2. QUOTATION REQUIREMENTS

Quotations are hereby invited for the provision of services for implementation and or upgrade of SAP Business One software as detailed on Annexure A.

The support required from the company providing the services include the following:

- SAP Business One upgrades from different version of SAP Business One upgrade – to AP Business One version 10
- Implementation of Eralis Job Costing and Project Management in one location, this must include licenses for 10 users
- Implementation for Fiori for ESS/MSS for one company

- Ability to integrate SAP Business One with other different third-party applications for manufacturing and production process in a variety of Manufacturing/ Mechanical Engineering industries.
- Implementation of Standard Project Management for SAP Business One.
- Ability of develop customised reports as per the requirements from the different companies.
- Implementation to be cloud based for some of the companies
- Ability for the solution to link or integrate with various Payroll applications (Sage VIP, CRS)
- Ability of multiple branches in different provinces or countries.
- Ability to develop bespoke solutions in line with the SAP Business One processes as per the customers' requirements.
- Ability to integrate all ISO systems
- Additional users to be procured for some locations per annexure A.
- Provide training on SAP Business One per location

3. MANDATORY REQUIREMENTS

- Be able to demonstrate to have an approved SAP ERP Business One reseller (South African Jurisdiction) access.
- Demonstrate a proven track record of at least 5 successful implementations of SAP in the manufacturing sector in RSA.
- Relevant and Contactable SAP Business One implementation references (not older than 3 years) for South African based companies.
- Training capability to staff (Please provide at least 3 companies of training from SAP business One recipient) for South African based companies
- Bidders to price as per quotation requirement, failure to do so will result to disqualification.
- Quotation submitted at wrong location or email address (Quote must be submitted via email to tender@csir.co.za before the closing date and time)

4. EVALUATION CRITERIA

- Selection of suppliers will be based on the 80/20 preference point system.
- No B-BBEE status will equal zero points (RSA suppliers only). Please submit valid BBBEE certificate or sworn affidavit.
- **Only the following documents shall be accepted as proof of a bidder's B-BBEE Status level of contributor:**

- B-BBEE Certificates issued by an accredited verification agency and bearing a SANAS logo
- Sworn affidavits
- Dtic issued sworn affidavit / BEE certificate

- Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register. *(Please ensure that tax status is updated on CSD)*

- No order will be issued, or no contract will be signed without a valid CSD number.

5. PRICING QUOTATION

- a. Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.

- b. Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.

- c. Payment will be according to the CSIR Payment Terms and Conditions.

6. OTHER TERMS AND CONDITIONS

- a. The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.

 - b. A validity period of 120 days will apply to all quotations except where indicated differently on the quote.
- 7. No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.**
