- 3.2 Suppliers that submit quotes late will not be evaluated.
- 3.3 Suppliers that submit incorrect email address will not be evaluated.
- 3.4 Suppliers who do not submit a completed SBD 1 form will not be evaluated.
- 3.5 Suppliers who do not submit a completed Declaration by Tenderer form will not be evaluated.
- 3.6 Only suppliers that quote as per specification will be evaluated.
- 3.7 Selection of suppliers will be based on the 80/20 preference point system.
- 3.8 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register.
- 3.9 No order will be issued or no contract will be signed without a valid CSD number.

4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated. The price quoted should be VAT inclusive in the case of the VAT registered service providers.
- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions.
